Subject: Declaration with respect to non-applicability of the provisions of Annual Secretarial Compliance Report under Regulation 24A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 for Financial Year ended March 31, 2024.

With reference to the above captioned subject, we would like to inform you that we are listed on NSE Emerge Platform of National Stock Exchange of India Limited (Hereinafter referred to as the said "SME Exchange –NSE") and as per the Regulation 15(2) of SEBI (Listing Obligation and Disclosure Requirements) Regulation, 2015, the compliance with the provision as specified in regulations 17, 17A, 18, 19, 20, 21, 22, 23, 24, 24A, 25, 26, 27 and clauses (b) to (i) and (t) of sub regulation (2) of regulation 46 and para C, D and E of Schedule V of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015 shall not apply in respect of a Listed entity which has listed its specified securities on the SME Exchange.

Hence being an entity listed on NSE Emerge Platform of National Stock Exchange of India Limited (Hereinafter referred to as the said "SME Exchange –NSE"), compliance under Regulation 24A of SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015 are not applicable to our company.
