Sub: Submission of Board's Comments on Fine Levied by NSE for Non-Compliance under Regulation 33 and its Current Status.

Ref: Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015.

This is with reference to the communication received from the National Stock Exchange of India Limited (NSE) vide letter no. NSE/LIST-SOP/FINES/0709 dated June 27, 2025, regarding non-compliance of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, with respect to the submission of Consolidated Profit and Loss Account.

In line with the Exchange's advisory, the matter was placed before the Board of Directors at its meeting held on August 07, 2025. Upon detailed discussion, the Board of Directors noted that the delay occurred due to an inadvertent clerical error while scanning and uploading the financial results. Specifically, the version of the Consolidated Profit and Loss Account that was initially submitted did not include the column for the half-year ended March 31, 2025, due to an unintentional omission. This was a procedural lapse without any malafide intent, and not a wilful or deliberate act of non-compliance. Upon identification of the error, the Company took immediate steps to rectify the submission and uploaded the corrected version of the financial results on June 27, 2025, demonstrating our continued commitment to transparency and regulatory compliance. The Board members also took note that the Company had submitted a detailed waiver request to NSE, clearly outlining the circumstances and emphasizing that the delay was unintentional and non-substantive.

Unfortunately, the Company's waiver request was not favourably considered by the Exchange. Accordingly, the penalty amount has since been duly paid by the Company in compliance with the Exchange's directive.

We sincerely regret the inadvertent lapse and assure you that appropriate corrective measures have been implemented to strengthen our internal controls and review mechanisms to prevent any such occurrences in the future.
